Invitation to Bid for Construction/ Repair/ Rehab of Public Buildings and Facilities, Lasam District Hospital Building Extension, Lasam, Cagayan

1. The *Provincial Government of Cagayan*, through the *QRF 2019* intends to apply the sum of **P 14,454,506.97** being the Approved Budget for the Contract (ABC) to payments under the contract for ***Construction/ Repair/ Rehab of Public Buildings and Facilities, Lasam District Hospital Building Extension, Lasam, Cagayan***. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Provincial Government of Cagayan* now invites ***Excavation Works, Backfilling of Excavated Materials, Backfilling, Gravel Bedding, Reinforced Concrete Column Footing, Reinforced Steel for Column Footing, Reinforced Concrete for Columns, Reinforced Steel for Column, Reinforced Concrete Tie Beam, Reinforced Steel for Tie Beam, Reinforced Concrete Grade Beam, Reinforced Steel for Grade Beam, Reinforced Concrete Roof Beam, Reinforced Steel for Roof Beam, Reinforced Concrete for Cantilever Beam, Reinforced Steel for Cantilever Beam, Reinforced Concrete Gutter, Reinforced Steel for Concrete Gutter, Reinforced Concrete Slab, Reinforced Steel for Concrete Slab, Reinforced Concrete Wall Footing, Reinforced Steel for Wall Footing, Masonry Works, Cement Plaster Finish, Doors and Windows (Supply and Installation), Tiling Works, Painting Works (use Davies paint or Approved Equivalent), Plumbing Works, Plumbing Works Septic Tank (6m x 2m x 1.8m), Electrical Works, Roofing Frameworks, Tinnery Works, Carpentry Works (Ceiling Works), Metal Works (#304 Stainless Steel Railing for Ramp and Stairs, Mechanical Works (Fire Fighting System Design, Supply and Installation), Temporary Facilities, Mobilization/ Demobilization, Scaffoldings and Formworks, Construction Health and Safety, Building Permit Fire Dept. and Related Building Documents*** .. Completion of the Works is required *288 days*. Bidders should have completed within ten (10) years from the date of submission and receipt of bids, a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from *Bids and Awards Committee of the Province of Cagayan* and inspect the Bidding Documents at the address given below from 8:00am to 5:00 pm, Mondays to Fridays.
5. A complete set of Bidding Documents may be acquired by interested bidders on July 25- Aug. 18, 2019 from the Bids and Awards Committee Secretariat, 2nd Floor GSO Building, Capitol Hills, Tuguegarao City, Cagayan upon payment of a nonrefundable fee in the amount of **P25,000.00**.


It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *Bids and Awards Committee* will hold a Pre-Bid Conference on Aug.02, 2019, 10:00 am at the *BAC Conference Room, 2nd Floor GSO Building, Capitol Hills, Tuguegarao City, Cagayan*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before Aug. 19, 2019, 9:00am. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on Aug. 19, 2019 10:30am at the *BAC Conference Room, 2nd Floor GSO Building, Capitol Hills, Tuguegarao City, Cagayan*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The *Provincial Government of Cagayan* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
