EXECUTIVE ORDER NO. 18
Series of 2020

AN EXECUTIVE ORDER ALLOWING TRANSPORT OF STRANDED STUDENTS TO THEIR RESPECTIVE MUNICIPALITIES OF RESIDENCE WITHIN THE PROVINCE OF CAGAYAN

WHEREAS, President Rodrigo Roa Duterte placed the entire Island of Luzon under Enhanced Community Quarantine on March 15, 2020 as an immediate measure against the spread of COVID19 in the country;

WHEREAS, the Province of Cagayan being the center of education in Region 02, numerous students were stranded in their dormitories and have been quarantined thereat since March 15, 2020, where they have been assisted and provided for by the Local Government Units;

WHEREAS, President has approved the recommendation of the IATF-MEID classifying the Province of Cagayan as moderate risk and will be placed under General Community Quarantine come May 1, 2020, under which classes will continue to be suspended;

WHEREAS, there have been no recorded COVID19 positive cases in the Province of Cagayan since April 3, 2020;

WHEREAS, the Provincial Health Officer has recommended that it is fairly safe to let the stranded students go home, and there is no necessity for further quarantine in their respective municipalities of residence;

NOW THEREFORE, I, MANUEL N. MAMBA, Governor of the Province of Cagayan, by virtue of the powers vested in me by existing laws, do hereby order that stranded students within the Province of Cagayan may go home, subject to the following protocols:

Section 1. TRANSPORT OF STUDENTS WITH RESIDENCE WITHIN THE PROVINCE OF CAGAYAN.

- a. Local Government Units of municipalities/cities hosting the stranded students (host LGU), observing social distancing and the wearing of appropriate protective equipment, shall transport said students to the Municipal/City Hall of their respective municipalities/city of residence (Home LGU).
- b. The Host LGU shall coordinate with the Home LGU the students' details, Estimated Time of Departure and Estimated Time of Arrival at the Home LGU Municipal Hall.
- c. The Home LGU shall then transport the students to their respective Barangays of residence, observing appropriate precautionary measures as the Home LGU deems necessary.

- a. The Home LGU need not subject the students to 14-day quarantine as they have been subject to quarantine by the Host LGU.

Section 2. TRANSPORT OF STUDENTS WITH RESIDENCE OUTSIDE THE PROVINCE OF CAGAYAN.

- a. The Host LGUs shall transport the students to the Provincial boundary of Cagayan where they will be received by their respective LGUs of residence.
- b. The Host LGU shall coordinate said transport to the Provincial Disaster and Risk Reduction Management Office (PDRRMO) and the students' LGUs of residence.
- c. The PDRRMO shall in turn coordinate the details of said transport to the students' respective Provincial Local Government Units of residence.


Section 3. The Host LGUs, the Home LGUs and the PDRRMO are to ensure the safety and safety of the students at all times;

Section 4. All executive orders, rules, regulations or other issuances, or parts thereof, which are inconsistent with this Executive Order are hereby revoked, amended or modified accordingly.

Section 5. Any portion or provision of this Executive Order that may be declared unconstitutional shall not have the effect of nullifying its other portions or provisions as long as such remaining portions can still be given effect.

Section 6. This Executive Order takes effect immediately.
