

Section I. Invitation to Bid

Republic of the Philippines Province of Cagayan Tuguegarao City

Invitation to Bid for the *Completion of Capitol Multi-Purpose Hall, Capitol Compound, Tuguegarao City, Cagayan*

March 21, 2017

1. The *Provincial Government of Cagayan* intends to apply the sum of **P6,288,919.79** being the Approved Budget for Contract (ABC) to payments under the contract for **Completion of Capitol Multi-Purpose Hall, Capitol Compound, Tuguegarao City, Cagayan**. Bids received in excess of the ABC shall be automatically rejected at Bid opening.
2. The *Provincial Government Cagayan* now invites potential Bidders for **Completion of Capitol Multi-Purpose Hall, Capitol Compound, Tuguegarao City, Cagayan**. Bidders should possess a valid PCAB license applicable to the above type and cost of the contract, have completed a similar contract with a value of at least 50% of the ABC, and meet the other minimum eligibility requirements stated in the eligibility forms. Completion of the works is required by *150 calendar days*.
3. Bidding will be conducted through open competitive bidding procedures as specified in the revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (R.A. 9184), otherwise known as the Government Procurement Reform Act. The Bidder with the Lowest Calculated Bid (LCB) shall advance to the post-qualification stage in order to finally determine its responsiveness to the technical and financial requirements of the project. The contract shall then be awarded to the Lowest Calculated Responsive Bidder (LCRB) who was determined as such during post-qualification.
4. Interested eligible Bidders may obtain further information from *Bids & Awards Committee of the Province of Cagayan* and inspect the Bidding Documents at the address given below from *8:00am to 5:00pm*, Mondays to Fridays.
5. A complete set of Bidding Documents may be issued to by the BAC Secretariat to interested Bidders from March 21 to April 10, 2017 upon payment of a nonrefundable fee in the amount of **P10,000.00**. The Bidding Documents shall be received personally by the bidder or his authorized representative.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) provided that bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

6. The *Provincial Government of Cagayan* will hold a Pre-Bid Conference open to all Eligible Bidders on *March 29, 2017, 10:45am* at the BAC Conference Room, 2nd Floor, GSO Building, Capitol Hills, Tuguegarao City, Cagayan.


7. Eligible Bidders must submit their Bids at the address below before *April 11, 2017, 10:45am at the BAC Conference Room, 2nd Floor, GSO Building, Capitol Hills, Tuguegarao City, Cagayan*. All Bids must be accompanied by a Bid Securing Declaration or bid security in the amount specified below:

Late Bids shall not be accepted. Bid opening shall be on *April 11, 2017, 10:45am at the BAC Conference Room, 2nd Floor, GSO Building, Capitol Hills, Tuguegarao City, Cagayan*. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address above.

8. The *Provincial Government of Cagayan* reserves the right to accept or reject any Bid, and to annul the bidding process and reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
