**RESOLUTION No. PB 024-1, S-2020**

**A RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT:  
"SUPPLY AND DELIVERY OF VARIOUS LIGHT VEHICLES (LOT 1 – 1 UNIT  
PICK UP TRUCK, DOUBLE CAB, 4 X 2, A/T DIESEL; LOT 2 – 4 UNITS PICK  
UP TRUCK, 4X2 M/T, DIESEL; LOT 4 – 1 UNIT VAN, 15-SEATER, DIESEL,  
M/T; AND LOT 6 – 10 UNITS MULTICAB TRUCK, M/T GASOLINE)"**

**WHEREAS**, the Provincial Bids and Awards Committee-Goods and Services (PBAC-GS) convened on August 11, 2020, 9:30 A.M. at the BAC Conference Room, 2<sup>nd</sup> Floor GSO Bldg., Capitol Hills, Alimannao, Peñablanca, Cagayan purposely to open the submitted sealed bid proposals of the participating bidders for the project: **"Supply and Delivery of Various Light Vehicles (Lot 1 – 1 unit Pick up Truck, Double Cab, 4 x 2, A/T Diesel; Lot 2 – 4 units Pick up Truck, 4x2 M/T, Diesel; Lot 4 – 1 unit Van, 15-Seater, Diesel, M/T; and Lot 6 – 10 units Multicab Truck, M/T Gasoline)"**; and to recommend AWARD thereof;

**WHEREAS**, examination on the documents submitted by the participating bidders was done on a **per Lot** basis. It started with the documents comprising the Technical Component of their respective bid proposals;

**WHEREAS**, in examining the documents for **Lot 1**, the COMMITTEE found out that the bidder – **Toyota Tuguegarao City** was ELIGIBLE and QUALIFIED to Bid; while **Nissan Commonwealth, Inc.** was declared as ineligible and was outrightly disqualified to bid on the ground that contradicting terms were stated in its "After Sales Service/Parts Warranty" *viz.* "This standard warranty period and distance shall be superseded by any warranty stipulation on the sales invoice, quotation, bid documents, price conformation, or similar documents that dictates the terms and conditions of the sales thereof". For **Lot 2**, **Toyota Tuguegarao City** was again declared as ELIGIBLE and QUALIFIED to Bid; while B.M. Domingo Motor Sales, Inc. was declared as ineligible and was outrightly disqualified to bid on the ground that contradicting terms were also stated in its "After Sales Service/Parts Warranty". For **Lot 4**, **Toyota Tuguegarao City** which is a lone participating bidder, was just the same declared as ELIGIBLE and QUALIFIED to Bid; and for **Lot 6**, **Elite North Autocars, Inc.** which is also a lone participating bidder was declared as ELIGIBLE and QUALIFIED to Bid;

**WHEREAS**, after having determined the Single Calculated Bid for each Lot, and subsequently having conducted a post-qualification thereon, **Toyota Tuguegarao City** is found to be the Single Calculated and Responsive Bid for **Lots 1, 2, & 4** while **Elite North Autocars, Inc.** is found to be the Single Calculated and Responsive Bid for **Lot 6**, and the same were considered the most advantageous offers in favor of the Provincial Government of Cagayan;

**WHEREAS**, the Abstract of Bids, which reflects the bid prices as read and the corresponding Calculated Bid Prices of the single qualified participating bidders each Lot, the Post-Qualification Report, Technical Working Group Report, and Bid Evaluation Report, are attached and made integral parts of this resolution;

**NOW, THEREFORE**, on motion duly seconded:

**RESOLVE**, as it is hereby **RESOLVED**, to recommend **AWARD** of the project/contract: **"Supply and Delivery of Various Light Vehicles (Lot 1 – 1 unit Pick up Truck, Double Cab, 4 x 2, A/T Diesel; Lot 2 – 4 units Pick up Truck, 4x2 M/T, Diesel; Lot 4 – 1 unit Van, 15-Seater, Diesel, M/T)**



**RESOLVED FURTHER** to recommend **AWARD** of the project/contract: **"Supply and Delivery of Various Light Vehicles (Lot 6 – 10 units Multicab Truck, M/T Gasoline)"** to the bidder, **Elite North Autocars, Inc.** for a contract price of **Five Million Six Hundred Ninety-Five Thousand Pesos (P5,695,000.00)** only,



**WHEREAS**, the Provincial Bids and Awards Committee - Goods and Services (PBAC-GS), through PBAC-GS Resolution No. 024-1, S-2020 dated August 20, 2020, recommended the award of the contract / project: **"Supply and Delivery of Various Light Vehicles (Lot 1 – 1 unit Pick up Truck, Double Cab, 4 x 2, A/T Diesel; Lot 2 – 4 units Pick up Truck, 4x2 M/T, Diesel; and Lot 4 – 1 unit Van, 15-Seater, Diesel, M/T"** to the bidder, **Toyota Tuguegarao City**; and **(Lot 6 – 10 units Multicab Truck, M/T Gasoline)** to the bidder, **Elite North Autocars, Inc.;**


**WHEREAS**, **Toyota Tuguegarao City** was the Single Calculated Responsive Bid for the contract comprising **Lots 1, 2, & 4** while **Elite North Autocars, Inc.** was the Single Calculated Responsive Bid for the same contract comprising **Lot 6**, and premises considered in the aforementioned resolution, the approval of the award thereof to Toyota Tuguegarao City and Elite North Autocars, Inc. by the Honorable Governor is deemed necessary;

THIS AGREEMENT made the 28<sup>th</sup> day of December, 2020 between the **Provincial Government of Cagayan** with office address at Capitol Hills, Alimannao, Peñablanca, Cagayan, (hereinafter called the "Entity") of the one part and **Toyota Tuguegarao City** with office address at Enrile Boulevard, Caggay, Tuguegarao City, Cagayan (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., "**Supply and Delivery of Various Light Vehicles (Lot 1 - 1 Unit Pick-up Truck, Double Cab, 4x2 A/T Diesel)**" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Million Three Hundred Thirty-Two Thousand One Hundred Pesos (P1,332,100.00)** (hereinafter called "the Contract Price"):


