
**PROVINCIAL BIDS AND AWARDS COMMITTEE**  
**INVITATION TO BID**

1. The Provincial Government of Cagayan, through the Annual Budget Appropriation intends to apply the sum of P1,131,490.00 being the Approved Budget for the Contract (ABC) to payments under the contract for Supply and Delivery of Brand New Cameras & its Accessories, and Video Microphone Kits & other Paraphernalia. Bids received in excess of the ABC shall be automatically rejected a Bid opening.
2. The Provincial Government of Cagayan now invites sealed Bids from eligible Bidders for Supply and Delivery of Brand New Cameras & its Accessories, and Video Microphone Kits & other Paraphernalia. Bidders should have completed, **within the last five (5) years**, a contract similar to the Project which must be at least fifty percent (50%) of the ABC. Delivery of the GOODS is required by 15 days. The description of an eligible Bidder is contained in Section II of the Bidding Documents, **ITB**.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the revised Implementing Rules and Regulations Part A (IRR-A) of Republic Act No. 9184 (R.A. 9184). Only Bids from Bidders who pass the eligibility check will be opened. The process for the eligibility check is described in Section II of the Bidding Documents, **ITB**. The bidder with the lowest calculated bid (LCB) shall advance to the post-qualification stage in order to finally determine his responsiveness to the technical and financial requirements of the project. The contract shall then be awarded to the Lowest Calculated and Responsive Bidder (LCRB) who was determined as such during the post-qualification procedure.
4. Interested Bidders may obtain further information from the Bids & Awards Committee of the Provincial Government of Cagayan and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm, Mondays to Fridays.
5. A complete set of Bidding Documents shall be issued by the BAC Secretariat to interested Bidders from January 29 - February 19, 2019 upon payment of a nonrefundable fee in the amount of Five Thousand Pesos (P5,000.00).
6. The Provincial Government of Cagayan will hold a Pre-Bid Conference open to all interested parties on February 6, 2019, 1:30pm at the BAC Conference Room, 2<sup>nd</sup> Floor GSO Bldg., Capitol Hills, Tuguegarao City, Cagayan.
7. Bids and eligibility requirements must be delivered on or before February 20, 2019, 9:30am at the BAC Conference Room, 2<sup>nd</sup> Floor GSO Bldg., Capitol Hills, Peñablanca, Cagayan. All Bids must be accompanied by a Bid security in the form of a Bid Securing Declaration or bid security in the form of Cash/Certified Check or Bank Guarantee in the amount of P22,629.80. Late Bids shall not be accepted.
8. Bid opening shall be on February 20, 2019, 9:30am at the BAC Conference 2<sup>nd</sup> Floor GSO Bldg., Capitol Hills, Peñablanca, Cagayan. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below.
9. The Provincial Government of Cagayan reserves the right to reject any or all bids, waive any defect and or formality, assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the presentation of the bid.
