INVITATION TO BID FOR *COMPUTERIZATION OF REAL PROPERTY TAX MANAGEMENT*

1. The *Provincial Government of Cagayan (PGC)*, through the *Annual Budget Appropriations (General Fund)* intends to apply the sum of *P10,000,000.00* being the *Approved Budget for the Contract (ABC)* to payments under the contract for *Computerization of Real Property Tax Management*. Bids received in excess of the *ABC* shall be automatically rejected at bid opening.
2. The *Provincial Government of Cagayan* now invites bids for *Installation / deployment of the GIS-based Electronic Real Property Tax Administration System (eRPTAS) in the PGC, ten (10) pilot LGUs and other qualifying non-pilot LGUs; Database build-up of real property units (RPU) of the ten (10) pilot LGUs and consolidation at the PGC; Installation of Network Cables, Equipment and Peripherals for the PGC and the ten (10) pilot LGUs; supply / delivery of one (1) data server, ten (10) workstations and other equipment and peripherals; and Trainings (eRPTAS, GIS, Networking)*. Delivery of the Goods is required *six (6) months or 180 days*. Bidders should have completed, within *five (5) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

4. Interested bidders may obtain further information from *Bids and Awards Committee (Goods and Services) of the Provincial Government of Cagayan* and inspect the

Bidding Documents at the address given below during *Mondays to Fridays from 8:00 A.M. to 5:00 P.M.*

5. A complete set of Bidding Documents may be acquired by interested Bidders on *March 1-21, 2019* from the address below *upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of P25,000.00.*


It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *Provincial Government of Cagayan* will hold a Pre-Bid Conference on *March 8, 2019, 11:00 A.M.* at *BAC Conference Room, 2nd Floor GSO Building, Capitol Hills, Alimannao, Peñablanca, Cagayan*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before *March 22, 2019, 9:00 A.M.* All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on *March 22, 2019, 11:00 A.M.* at *BAC Conference Room, 2nd Floor GSO Building, Capitol Hills, Alimannao, Peñablanca, Cagayan*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The *Provincial Government of Cagayan* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
