INVITATION TO BID FOR SUPPLY AND DELIVERY OF FIVE (5) UNITS BRAND NEW GENERATOR SETS AND FIVE (5) UNIT BRAND NEW MCCB TYPE AUTOMATIC TRANSFER SWITCH (ATS) INCLUDING THE INSTALLATION AND COMMISSIONING

1. The *Provincial Government of Cagayan*, through the *Annual Budget Appropriations (General Fund)* intends to apply the sum of *P4,000,000.00* being the Approved Budget for the Contract (ABC) to payments under the contract for *Supply and Delivery of Five (5) Units Brand New Generator Sets and Five (5) Units Brand New MCCB Type Automatic Transfer Switch (ATS) including the Installation and Commissioning*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Provincial Government of Cagayan* now invites bids for *Supply and Delivery of Five (5) Units Brand New Generator Sets and Five (5) Units Brand New MCCB Type Automatic Transfer Switch (ATS) including the Installation and Commissioning*. Delivery of the Goods is required *60 days*. Bidders should have completed, within *the last five (5) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

4. Interested bidders may obtain further information from *Bids and Awards Committee - Goods and Services (BAC-GS) of the Provincial Government of Cagayan* and inspect

the Bidding Documents at the address given below during *Mondays to Fridays from 8:00 A.M. to 5:00 P.M.*

5. A complete set of Bidding Documents may be acquired by interested Bidders on *May 31 to June 24, 2019* from the address below *upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of P5,000.00.*


It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *Provincial Government of Cagayan* will hold a Pre-Bid Conference on *June 11, 2019, 2:30 P.M.* at *BAC Conference Room, 2nd Floor GSO Building, Capitol Hills, Alimannao, Peñablanca, Cagayan*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before *June 25, 2019, 9:00 A.M.* All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on *June 25, 2019, 10:30 A.M.* at *BAC Conference Room, 2nd Floor GSO Building, Capitol Hills, Alimannao, Peñablanca, Cagayan*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The *Provincial Government of Cagayan* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its revised IRR, without thereby incurring any liability to the affected bidder or bidders.
