INVITATION TO BID FOR *Supply and Delivery of Various Medical Supplies and Equipment*

1. The *Provincial Government of Cagayan*, through the *Annual Budget Appropriations (General fund) and Trust Fund* intends to apply the sum of P 1,000,500.00 , for Lot 1, P 470, 350.00 for Lot 2 and P 430, 000.00 for Lot 3 and being the Approved Budget for the Contract (ABC) to payments under the contract for the *Supply and Delivery of Various Medical Supplies and Equipment*. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
2. The *Provincial Government of Cagayan* now invites bids for *Supply and Delivery of Various Medical Supplies and Equipment*. Delivery of the Goods is required 30 days. Bidders should have completed, within the last five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.
4. Interested bidders may obtain further information from *Bids and Awards Committee - Goods and Services (BAC-GS) of the Provincial Government of Cagayan* and inspect the Bidding Documents at the address given below during *Mondays to Fridays from 8:00 A.M. to 5:00 P.M.*
5. A complete set of Bidding Documents may be acquired by interested Bidders on *November 13- December 3, 2019* from the address below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of P5,000 for Lot 1, P 500 for Lot 2 and P500.00 for Lot 3.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity,

provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *Provincial Government of Cagayan* will hold a Pre-Bid Conference on *November 20, 2019, 9:30 A.M.* at *BAC Conference Room, 2nd Floor GSO Building, Capitol Hills, Alimannao, Peñablanca, Cagayan*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before *December 6, 2019, 9:00 A.M.* All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on *December 6, 2019, 2:00 P.M.* at *BAC Conference Room, 2nd Floor GSO Building, Capitol Hills, Alimannao, Peñablanca, Cagayan*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.


